

Overview of supplementary costs and surcharges 2024 Van Duuren

Fuel premiums

No fuel premium shall be applicable as long as the price of diesel fuel at the pump remains within the range of € 1.10 - € 1.30 per litre including VAT (see www.ok-olcentrale.nl). Outside this range a fuel premium will automatically become applicable, whereby each variation (upwards or downwards) of € 0.05 per litre including VAT results in an adjustment (upwards or downwards) of 1% to the applicable tariffs. The surcharge shall be determined at the beginning of each month by calculating the average price during the previous month.

Currency Adjustment Factor (CAF)

The CAF shall be calculated for all consignments to and from Switzerland and consignments in transit to and from Italy and consignments to and from the United Kingdom. These costs arise relating to the exchange rate between the Euro and the Swiss Franc (CHF). CH Range, 1 CHF → € 0.820 - € 0.829. Outside this range an automatic surcharge of 0.50% is applicable to every € 0.01 increase. IT Range CHF → € 0.820 - € 0.829. Outside this range an automatic surcharge of 0.25% is applicable to every € 0.01 increase. UK Range 1 £ → € 1.20 - € 1.30. From € 1.31 - € 1.319 a surcharge of 2.5% is applicable. For every further increase of € 0.01 a surcharge of 0.42% is applicable.

Customs processing and/or clearance

Consignments requiring customs clearance will be dealt with by our business partner Jac Goenee Douane Expeditie B.V.

Costs for EXPORT from the Netherlands

NL Export **customs documents** € 65.00 including 3 HS codes. Each subsequent HS code costs € 7.50.
 CH Import **customs documents** € 85.00 including 3 HS codes. Each subsequent HS code costs € 7.50.
 UK Import **customs documents** € 85.00 including 3 HS codes. Each subsequent HS code costs € 7.50.
 NO Import **customs documents** € 110.00 including 3 HS codes. Each subsequent HS code costs € 7.50.

Costs for IMPORT into the Netherlands

NL Import **customs documents** € 65.00 including 3 HS codes. Each subsequent HS code costs € 7.50.
 CH Export **customs documents** € 85.00 including 3 HS codes. Each subsequent HS code costs € 7.50.
 UK Export **customs documents** € 85.00 including 3 HS codes. Each subsequent HS code costs € 7.50.
 NO Export **customs documents** € 110.00 including 3 HS codes. Each subsequent HS code costs € 7.50.

Advance commission

Amounts advanced, including import duties, taxes and other government levies, shall be charged to the Client in arrears including a 3% surcharge on the amount advanced with a minimum of € 30.00 on the VAT and Import Duties and other Government levies advanced.

T1-T2

Formatting/attaching T1/T2 to shipment on export or closing T1/T2 on import € 25.00 per document incl. including 3 HS codes. Each subsequent HS code costs € 7.50

Physical inspection by Customs

Should a physical control by Customs be required, the costs for this are € 40.00 per shipment.

Waiting time

Surcharge for waiting time. Waiting costs during loading and unloading that occur beyond the responsibility of Van Duuren will be charged for at € 77.00 per hour. The loading/unloading time amounts to a maximum of:

Eight hours will be charged for a full waiting day.

Surcharge for tail lift

Van Duuren's international trailers are not equipped with tail lifts as standard unless this concerns a delivery via the distribution network. Costs for part- and/or full loads are available on request.

Proof of Delivery

PODs are available free of charge via the Van Duuren website. A POD requested via Customer Service costs €10.00. Van Duuren does not attach hard copies of delivery notes to the invoice.

ADR Goods

The tariffs are applicable for normal commercial goods. For ADR goods in the European Distribution Network a surcharge of € 30.00 per consignment is applicable. Costs for part- and/or full loads are available on request.

It is possible that that for such consignments the lead time to the final destination will be affected.

Time windows

- In the case of a timed delivery for EU countries, a surcharge is applicable of:
 € 75.00 for delivery before 10.00 a.m.
 € 47.50 for delivery before 12.00 p.m.
- For a shipment with a (fixed) time window smaller than 1 hour, outside the above-mentioned time windows or a collection with time window, the option is on request and the surcharge for this is € 110.00.
- Day definite fixed Delivery for EU countries is according to a surcharge of € 35,00
- Priority deliveries into Germany are against € 20,00

Extra long cargo

The following surcharges are applicable for **extra long cargo** (maximum 6 metres):

2.40 - 3.0 metres € 60.00 per consignment	4.01 - 5.0 metres € 120.00 per consignment
3.01 - 4.0 metres € 90.00 per consignment	5.01 - 6.0 metres € 155.00 per consignment

For airfreight consignments longer than 2.40 metres the possibilities and costs are available on request.

Deliveries to the Dutch Wadden Islands

For consignment to the Dutch Wadden Islands (Texel, Vlieland, Terschelling, Ameland and Schiermonnikoog) a supplement of 100% of the freight cost is applicable.

Deliveries to the German Islands

For shipments to all German islands a surcharge is due which is available on request. This surcharge is applied to the following postal codes: 25849, 25859, 25869, 25883, 25938, 25946, 25980, 25992, 25996, 25997, 25999, 26465, 26474, 26486, 26548, 26571, 26579,

Second attempt at delivery

For a second attempt at delivery a surcharge is applicable:

To National Network consignments	100%.
To International Network consignments	70%.
To non-network consignments	in consultation with the Planning Department.

Refused consignments and notification

For refused consignments that must be brought back, a surcharge is applicable that is equal to the cost of the outward freight plus refusal costs of € 15.00 per consignment.

Notification of booking consignments

Delivery to consignees requiring notification by means of a booking form, e-mail notification, website, booking portals and/or the like is subject to a surcharge of € 35.00. For Amazon deliveries, an additional surcharge of € 75.00 including 5 waiting days applies.

For a (telephone) pre-registration, a surcharge of € 12.00 applies.

If a time-limited appointment results from this, the surcharges according to the article '**Time windows**'.

Cancellation of consignments

Cancellation of consignments within a period of 24 hours before time of collection is treated as so-called 'dead freight' with surcharges of:

Cancellation the day before loading < 16.00 hours =	70% of the agreed tariff.
Cancellation the day before loading > 16.00 hours =	100% of the agreed tariff.
Cancellation on the day of loading =	100% of the agreed tariff.

Airfreight FTL can be cancelled up to 12 hours before departure, after which 70% of the agreed freight price will be charged.

Airfreight LTL can be cancelled up to 12 hours on the day of departure, after which 70% of the agreed freight price will be charged.

Deliveries to private individuals – Direct-to-Consumer

Applicable to deliveries to private addresses is a surcharge of € 17.50 per consignment.

This surcharge includes the notification of the consignment booking.

In the event of a time limiting agreement, the surcharges applicable can be found in the article '**Time windows**'.

Manual booking

For all shipments which are not offered digitally a surcharge of € 20.00 per shipment is applicable

Disputes

In the event of any dispute connected with these costs/surcharges the Dutch language version of this document is valid in law.
